## Blind tastings

bonvinitas is organizing combined with the magazine blind evaluations of international wines and sparkling wines by groups of experts. The points are allocated according to the 100-point system, **in five classes**: ① **dry** up to and including 12 %vol. alcohol (green points). ② **dry** with more than 12,5 %vol. alcohol (red points). ③ **sweet** wines with more than 9 g/l sugar (orange points). ④ **noble sweet** wines (violet points). ⑤ **natural and orange** wines (earth-coloured points)

According to our system the points will say ([read more](#)):

**87 to 89 points: very good**

**90 to 94 points: excellent**

**95 points and up: extraordinary**

The evaluations are held at shorter intervals continuously. **The owners, partners and employees of bonvinitas don't participate and have no influence on the results.**

## Publication

From 87 points we **publish all wines in the bonvinitas wine guide in English and German.** Furthermore **we release articles, reading about the wines and its producers**, too, as well as **bonvinitas Wine Tips**.

## Use your points



The submitter may use the points from 87 upwards for his website, his marketing and sales materials, the bonvinitas logo, too; although obviously only for the wines, which we had rated. You may also add a link to your wines in the bonvinitas wine guide.

## Conditions

1. This price list supersedes all previous ones.
2. bonvinitas samples and assesses the submitted wines in blind tastings with groups of experts. The owners, partners and employees of bonvinitas have no influence on the results.
3. The results from 87 points upwards are published at [www.bonvinitas.com](http://www.bonvinitas.com) together with more details about the wine, a brief presentation of the producer and the name of **one** source of supply. The submitting party can use the results from 87 points upwards for his marketing and sales materials, as well as the bonvinitas logo, although only with reference to the relevant wine. Other uses of the bonvinitas logo are prohibited. The bonvinitas certificates may be hanged up in the business premises of the submitting party without constraints. The results and the bonvinitas logo are copyrighted furthermore the logo is a registered brand.
4. The request is placed by submitting an application form to be found on [www.bonvinitas.com](http://www.bonvinitas.com). Would you please fill it in, print and send it to bonvinitas along with two samples of each wine free of charge and also covers the costs of sending. Only applications made within 14 days are considered a closed batch of several wines with one basic fee.
5. The submitting party declares with his signature on the application that he has read and accepted these conditions, that he is entitled and authorised for submitting, that he accepts the current price list and that the above-mentioned publication by bonvinitas is permitted. It is hereby confirmed that these conditions on the reverse side of the original application form or on the reverse side of the price list, or, in the case of an electronic application, at [www.bonvinitas.com](http://www.bonvinitas.com) have been noted.
6. After making the application, the submitting party receives a fee invoice. Any customs clearance or shipping charges are on the submitter's account.
7. In each case, the results represent the opinion of the tasting group. Attempts to influence the groups or bonvinitas are not permitted and can lead to the wines being excluded from the tasting. In this case, the submitting party is not entitled to a refund of the fees. The selection of tasters is reserved by bonvinitas.
8. Results of less than 87 points shall not be published and no certificates shall be issued. This does not entitle you to the reimbursement of participation fees. The submitting party cannot make any references to bonvinitas for such wines.
9. The submitting party ensures the truthfulness of the brief presentation provided and also ensures that he has the rights to the images, labels and graphics, which he provided to bonvinitas for publishing.
10. Moreover, the submitting party ensures that the source of supply named is correct and that the provided sample corresponds to the wine offered by the source of supply named.
11. No submitting party is entitled to the return of the provided samples.
12. The submitting party waives the right to any complaint or claim for damages against bonvinitas, its owners, partners, employees and/or tasters concerning the tastings and results apart from deliberate intention or culpable negligence.
13. The submitting party indemnifies bonvinitas against any claims of third parties which could arise from his participation in tasting and/or the above-mentioned publication, and in such a case he is liable for them himself.
14. The place of jurisdiction is Achern.
